MEGA 50/50 Rules 2023

- 1. Draw Date: Kids Cancer Care Foundation of Alberta's MEGA 50/50 will be held on September 8, 2023 at the office of Stride Management Corp. 3950 12 St. NE Calgary, AB T2E 8H9. Only tickets purchased before 11:59 pm on September 7, 2023 will be eligible for the draw.
- 2. Prize draw will select one (1) winner at random. All draws are open to the public and will be completed using Random Number Generator (RNG). Two executive members of the Foundation, or their delegates, will be present as witnesses at the draw.
- 3. Tickets will not be sold outside of the province of Alberta.
- **4.** Winners will be notified by telephone and/or email. The winner will also be posted on the Kids Cancer Care Foundation webpage.
- 5. Should the prize not be claimed within three months of the draw date, a request will be made to Alberta Gaming, Liquor & Cannabis for a decision regarding the disbursement of the prize.
- 6. Contest guidelines prohibit the following people from purchasing tickets in the Raffle:
 - Kids Cancer Care Foundation of Alberta Board members and members of their immediate family including spouse, parents, children, or siblings who reside in the same household.
 - Kids Cancer Care Foundation of Alberta Management team and members of their immediate family including spouse, parents, children, or siblings who reside in the same household.
 - All Partners and employees of Stride Management Corp. and their spouses and family.
 - Anyone under the age of 18. The Licensee will advise all purchasers not to include the name of anyone under the age of 18 on the ticket due to the requirements of the Public Trustee Act
- 7. All sets of multiple tickets must contain the same information.
- 8. In the event that a winning ticket stub lists more than one name, the Licensee will award the prize to the individual whose name appears first on the stub. The Licensee, Stride Management, or Alberta Gaming, Liquor & Cannabis are not responsible for resolving any disputes that may arise between the different individuals.

- **10.** There will be one prize of 50% of total ticket sales. The Winner will be notified by telephone and/or by email by lottery representatives; detailing what they have won and where they can claim their prize. - **11.** All tickets will be controlled by Stride Management Corp. and are only available for purchase online.
- 12. Tickets may be purchased with MasterCard, Visa, or Debit.
- 13. If any purchased ticket has been entered for the draw, no refund will be issued.
- **14.** A minimum of 3,300 tickets must be sold by July 21, 2023. If 3,300 tickets are not sold by this date, Kids Cancer Care Foundation of Alberta reserves the right to contact AGLC and ask for both ticket sales and draw extensions.
